Boston Chapter Executive Committee Report: Jeff Carlson

Proposed Rule Changes: Carl Gustenhoven

- A motion was submitted to revise Rule 3.6 (Discontinuance of Leadership Status). A first vote on this change was approved. A second vote will be required in January.
 - 3.6: change "may" to "shall", yielding "Discontinuance of Leadership Status: A person's leadership status, inclusion on the Leaders List and privilege to lead shall be discontinued under any of the following circumstances:"
 - 3.6.2: Strike "; provided, however, the Committee shall take the following steps before discontinuing their status:", leaving "if a leader or Co-leader has not led a hike for two calendar years.
 - 3.6.2.1: Delete.
 - 3.6.4: Insertion to yield: "by vote of the Committee to enforce its rules or, in the unfettered opinion of the Committee, for the safety of the membership."
- A second vote was taken and approved to revise Rule 6.14's narrative by deleting from it "in the AMC Outdoors, the Charles River MUD or any other publication of the AMC or Committee", leaving: "Notice of Trip or Activity is a notice which describes an activity or a trip and invites participants to take part and which is submitted to the Trip Coordinator via the AMC Activity Database (or successor mechanism thereof) for publication by the AMC or one of the Committees of the AMC for distribution to members and others."
- A policy was approved to extend the definition (and rule relevance) of "winter" to include winter conditions in the three seasons.
- A policy was approved to empower Trip Coordinators to not approve (or in the presence of new information, rescind approval for) an activity that does not comply with H/B rules and policies.

- Alex Nedzel voted in as the Committee Chairman
- Stephen Conlin was nominated by Alex Nedzel for Vice Chair
- Faith Pulis remains Secretary
- Carl Gustenhoven remains Trip Coordinator
