OPERATIONAL UPDATES

Executive Committee Report - Paul Terenzi

- Training Reimbursement
 - 100% reimbursement for training that is required for leaders at various committees WFA, Advanced WFA, CPR for most committees

Paddling has separate requirements - Swift and open water rescue

- chapter treasurer will reimburse the committee
- Individual requests go thru the committee
- Leadership Training
 - 24of 32 slots have been registered
 - Class dates: April 14, 21 and weekend of April 29.
 - Trip planning meeting is May 5th (great way to meet new co-leaders)

Treasurers Report - Fred Smith

- The HB balance has been running the "teens of thousands." This is slightly lower than our historic level and this is attributed to the reduced pricing structure of the winter and spring hiking programs. The pricing structure will be reviewed at the next meeting.

- REGI Changes/Enhancements

Spring Hiking Program - Elizabeth Ryan

 - Non-Members: 16
 - 90 participants attended first class. Many emailed to say they were missing class for one reason or another

Leadership Applications

- Liz Westner and Tony Ng were approved to be 4 season leaders.
- John Pike and Ian Jessen were approved to be 3 season leaders.

DISCUSSION ITEMS

- a. Potential changes to the leadership requirements:
 - i. 3 season leaders:
 - 1) The applicant must be an AMC member in good standing.
 - The applicant shall have completed a leadership training course approved by the Committee or demonstrate experience which the Committee deems to be equivalent
 - 3) The applicant must have been be in compliance with the Committee's Wilderness First Aid requirements at the time of applying for three-season leadership status
 - 4) The applicant must have hiking/backpacking experience deemed by the committee to have presented the applicant with a sufficient breadth of challenges and contingencies to be prepared to lead the types of trips desired in a safe and fun manner
 - 5) The applicant must have conducted at least 3 total co-leads, under the direct supervision of 3 different 3 or 4 season H/B leaders
 - a) At least 2 co-leads must be organized and run as 3-season trips, in 3-season conditions must be in effect on those trips
 - b) At least 2 co-leads must take place within 1 year of the application date
 - c) No more than one co-led program trip can count
 - 6) The applicant must demonstrate competence in leadership and relevant threeseason hiking and backpacking skills to the satisfaction of the Committee
 - 7) The applicant must demonstrate to the satisfaction of the Committee that he or she understands the limits of his or her abilities, and will only lead trips within the bounds specified in his/her application
 - ii. 4 season leaders:
 - 1) The applicant must be an AMC member in good standing
 - 2) The applicant must be a fully active 3-season H/B leader
 - 3) The applicant must have hiking/backpacking experience deemed by the committee to have presented the applicant with a sufficient breadth of challenges and contingencies to be prepared to lead the types of trips desired in a safe and fun manner
 - 4) The applicant must have conducted at least 5 total co-leads, under the direct supervision of 3 different 4-season H/B leaders
 - a) All co-leads must be organized and run as calendar winter trips
 - b) Winter conditions must be in effect on each co-led trip
 - Suggestion made that the applicant have some above tree line experience. One recommendation was that at least one co-led trip must be materially above tree line
 - d) No more than one co-led program trip can count
 - 5) The applicant must demonstrate competence in leadership and relevant 4-season hiking and backpacking skills to the satisfaction of the Committee
 - 6) The applicant must demonstrate to the satisfaction of the Committee that he or she understands the limits of his or her abilities, and will only lead trips within the bounds specified in his/her application
 - iii. Grandfather existing rules if the candidate took the leadership training course before the new rules take effect.
- b. Leader Candidate Evaluations, things to consider:
 - Leader and coleader complete a standard online form immediately upon completing a trip that is stored for future reference and becomes the supporting documentation for the leadership application

- ii. Young Members has developed an on line system
- iii. Leadership subcommittee (Pam, Elizabeth et al) to meet with Phil Barona and investigate

c. Trip Feedback:

- i. The present feedback button is available only to participants and the results are sent to the webmaster and chairperson (Casey and Alex.) It is not automated and the participant must return to Regi to access it.
- ii. It is separate from the complaint form
- iii. Casey will look at updating the auto e-mail to participants feature.
- iv. We need to decide who should receive the results.
- d. Potential rule changes regarding Conduct/Harmony: Rule changes were submitted that would codify cooperation and coordination among leaders:
 - Proposal 1: Conduct Members who have achieved Leader or Leader Candidate status shall promote and facilitate the goals and objectives of the AMC, the Chapter, and the Hiking/Backpacking Committee. Leaders and Leader Candidates shall work cooperatively to coordinate and support all activities and events of the club and committee to the extent practicable. Leader or Leader Candidates will abide by the AMC Code of Conduct.
 - ii. Proposal 2: Harmony Members who have achieved leader or co-leader status have joined a team that will promote and facilitate the goals and objectives of the AMC and the Hiking and Backpacking Committee. This team will work cooperatively to coordinate and support all activities and events of the club and the committee as much as possible. No leader or co-leader will knowingly take any deliberate action that could jeopardize or complicate another event or activity of the AMC or the Committee or that could reflect poorly upon the AMC, the Committee, or another leader or co-leader.

These alternatives were discussed and will be reviewed and considered at future meetings.

An aspect of the discussion will be whether HB needs a clear statement in the HB rules or if it should lie under the umbrella of the AMC.

Faith Salter confirmed that, although these concepts are implied by the spirit, rules, policies, etcetera of the club; there is no clear concise statement in a prominent document.

Although a conceptually good idea to reference and incorporate the AMC Code of Conduct, probably best to wait until it is updated by the club.

EXECUTIVE SESSION

An executive session was conducted from 08:22 to 08:48 over the objection of Paul Terenzi. The result of the session was that Faith Salter will provide a statement regarding certain leadership issues, to be shared with all who received a lengthy complaint document from an H/B leader.

[Ed: Subsequent to the meeting, Faith provided the following public statement that may be shared with all concerned parties:

"AMC staff received a letter of complaint against five members of the Boston Chapter. After careful consideration including reviewing two communications made by Mr. Glenn in reference to two different AMC members, Volunteer Relations and Risk Management staff have decided to

revoke his Leader status including all co-leader rights. If you have questions, please contact Faith Salter (617) 391-6614 or Aaron Gorban (603) 466-8054."]
